**b. Relationships between PPGs and local Healthwatch" Survey:** Just a few days till the May 26<sup>th</sup> deadline for the online survey we sent to member groups in April.! Over 400 PPGs have participated. but if yours hasn’t, please do so on behalf of your PPG.

### **2. Access to General Practice**

A parliamentary report looks at patient access to general practice services during core hours, expressing concerns over rolling out extended access without a full understanding of issues in the variation in patient experience in accessing services. The report also raises concerns about the workforce supply in general practice and how this will impact on plans to roll out extended hours.

### **3. What does improving population health really mean?**

Everybody in NHS policy seems to be talking about population health. New care models are being developed to improve population health. Sustainability and transformation plans (STPs) – the local plans for redesigning NHS and social care services – will, we are told, develop into partnerships to improve population health. And health care leaders in other countries, such as the United States, are also using the language of population health to define the aims of their health systems. A paper from the King’s Fund asks what does improving population health really mean? And what does it mean for the NHS?

### **4. General Practice Forward View – one year on**

One year on from its launch, the BMA, the trade union and professional body for doctors in UK, has produced a report on the progress of the GPFV. ## 5. General Practice Awards 2017

The General Practice Awards celebrate projects and initiatives taking place across the UK. There are various primary care categories, including GPs, nurses and practice managers. ## 6. Blood pressure self-screening in general practice waiting rooms

A study by researchers from the University of Oxford found that making more blood pressure monitors available and accessible for patients in GP waiting rooms could increase the detection of high blood pressure and better enable patients being treated for high blood pressure to monitor and control their condition. While some patients without a history of high blood pressure often checked their blood pressure while waiting for a GP appointment, many patients often don't know about availability of self-measurement and may need help with the technique. Some patients were concerned about measuring blood pressure in a public place. Several preferred monitoring their blood pressure in the waiting room, to doing it at home.

## 7. What is social care and how does it work?

This is the title of a set of resources which King's Fund has pulled together, providing a range of content to help explain social care in England, including a series of short videos, which can be accessed [here](#). The King's Fund is an independent charity working to improve health and care in England.

## 8. Provision of community care: who, what, how much?

The Health Foundation is an independent charity committed to bringing about better health and health care for people in the UK. It has published a briefing which analyses information on the community care contracts held by 78% of CCGs in England to enable better understanding of the provision of these services. Following a Freedom of Information (FOI) request, they found that NHS providers held more than half of the total annual value of contracts in the sample, while private providers held 5% of the total annual value, but 39% of the total number of contracts issued. Private providers tended to hold much smaller contracts, with 6 in 10 holding contracts with a combined value of less than £100,000. Additionally, most held just one contract.

## 9. The cost of dementia care and support

A report by Alzheimer's UK reveals that nearly half of the UK adults surveyed had not started saving for the care and support they might need in the future, and a third agreed that they had not considered the cost of dementia care and support. The report reveals ongoing stigma around dementia and calls for greater support and access to information. The charity warns the bill will topple 'generation rent', who have fewer assets than previous generations, and are at higher risk of developing dementia as people continue to live longer.
